



## 2023-2024 Election Cycle Disbursements

Each year, thousands of community bankers across the nation contribute to ICBA PAC, the only federal political action committee dedicated exclusively to promoting community banks. Powered by the contributions of community bankers, ICBA PAC was able to support over 300 federal candidates during the 2023– 2024 election cycle, directing over \$1.47 million in campaign contributions to policymakers that are allies to our industry.

Together with input from community bankers and state partners, the advocacy team at ICBA takes pride in carefully evaluating which federal candidates and committees to support each election cycle. ICBA PAC uses a bipartisan approach to evaluate candidates and committees that demonstrate a commitment to supporting community banking priorities. ICBA PAC focuses on policymakers assigned to committees of key legislative jurisdiction, have representation of community banking locations, serve in Congressional leadership roles and have favorable election dynamics.
